## HANSEL AND GRETEL PRESCHOOL CONTRACT

THIS AGREEMENT made this 15th day of July 2016, by and between Hansel and Gretel Preschool Inc. (hereinafter referred to as "SCHOOL") and the parents of \_\_\_\_\_ of the County of Waseca, State Of Minnesota, (hereinafter referred to as "PARENT").

WHEREAS. PARENT'S child is now formally registered in the SCHOOL for the 2 day a week program for the term 2016-2017 and execution of this agreement completes the registration;

WHEREAS, SCHOOL and PARENT acknowledges that the execution of this agreement is necessary for the planning necessary to meet the physical and emotional needs of the child at SCHOOL;

NOW, THEREFORE, It is mutually agreed as follows:

### I

That classes will be held on Tuesday and Thursday for the 2 day program from 12:15 PM to 2:45 PM. Parents may bring their child at 12:00 for no additional charge.

### II

That transportation shall not be provided by the SCHOOL and that the SCHOOL shall not be responsible for organizing car pools. The SCHOOL shall receive prior notice from the PARENT in the event that someone other than the PARENT or the designated car pool driver for the PARENT is to pick up the child. The PARENT shall escort the child into the SCHOOL facility each day and shall pick up the child promptly at dismissal time. The SCHOOL will assess a \$5.00 charge per 15 minutes that the PARENT or care giver is late picking up the child.

### III

The PARENT shall furnish the SCHOOL with proof of a physical examination within six (6) months prior to the admission to the SCHOOL and the health form must be completed and returned to the SCHOOL by PARENT in August.

**IV**

The Parent agrees to furnish the SCHOOL with the name, home phone number, business phone number and address of the contact person in the event of an emergency and the name of a physician specified by PARENT on forms provided by the SCHOOL. By executing this agreement, the PARENT authorizes the SCHOOL to transport the child, in the event of an emergency, to the Waseca Hospital for emergency treatment.

**V**

The PARENT covenants and agrees to pay to the SCHOOL as and for tuition, the sum of \$828.00 for the 2 day program for three year olds, payable as follows: \$92.00 on the 1st day of August and \$92.00 on the 1st day of each month thereafter until the entire sum of \$828.00 is paid in full. PARENT covenants and agrees to pay the full tuition of \$828.00 for the term of 2016-2017 regardless of the time at which the PARENT terminates the child's enrollment with the SCHOOL. PARENT also covenants and agrees to pay for any costs of collection, including reasonable attorney's fees in the event that PARENT fails to pay the SCHOOL term tuition set forth herein. Release from this contract can occur only when the PARENT petitions the BOARD OF DIRECTORS and it is approved by that BOARD. The parent also agrees to pay a one time activity fee of \$80, due August 1<sup>st</sup>, which covers the costs of parties, activities, and part of the insurance costs.

**VI**

It is the policy of the SCHOOL, that if at the end of six weeks in school, it appears that a child is not socially or emotionally ready, a conference shall be held including the classroom TEACHER, the AIDE, the BOARD OF DIRECTORS to review the progress of the child involved. Further assessment can be requested by PARENTS or SCHOOL where a learning problem is suspected. A decision will be made by the SCHOOL whether the child should continue in the classroom.
